Please read these notes before completing the ***Security-Sensitive Dangerous Substances Application for Exemption of "low-scale restricted activity."***

Exemption Certificate holder	Means a person issued with a Security-sensitive Dangerous Substances Exemption Certificate of "low scale restricted activity" in accordance with section 78 of the <i>Security-sensitive Dangerous Substances Act 2005</i> . The person so named on the exemption certificate will be the person or a relevant officer of a corporation or agency in whose name the exemption instrument is listed.
Low-scale Restricted Activity	"Low Scale Restricted Activity" means – (a) The acquisition, storage, possession, handling and use of less than 3 kilograms of an SSDS by and for the purposes of an educational, research or analytical laboratory; or (b) A prescribed restricted activity
Restricted Activity	"Restricted Activity", in relation to an SSDS, means – (a) Manufacturing, importing, exporting, buying, selling, supplying, storing, using or disposing of any quantity of the SSDS; or (b) Transporting more than 20 kilograms of the SSDS; or (c) A prescribed activity carried out in relation to the SSDS
SSAN	Means Security-Sensitive Ammonium Nitrate, as described in Part 2 of Schedule 1 of the <i>Security-sensitive Dangerous Substances Act 2005</i> .
SSDS	"SSDS" means a Security-Sensitive Dangerous Substance
Director	Means the Director of Industry Safety appointed under section 33 of the <i>Workplace Health and Safety Act 1995</i>
