Information Sheet

Certificate of Competency in Gas Fitting (Natural Gas)

Workplace Health and Safety Regulations 1998, Regulation 39

Regulation 39 of the Workplace Health and Safety Regulations 1998 requires a person to be the holder of a certificate of competency in relation to the specified task they intend to perform.

A certificate of competency can be obtained from Workplace Standards Tasmania for the specified task – Gas Fitting (Natural Gas) – in the following categories: –

Gas Fitting (Natural Gas) Type A Appliance - Covers all gas fitting work except gas fitting work classified as of Gas Fitting Type B Appliances

Note: A **Type A Appliance** means an appliance (including a second hand appliance) for which an Australian Gas Association (AGA) / Australian Liquefied Petroleum Gas Association (ALPGA) approval scheme exists or existed, or has otherwise been approved by the Director of Gas Safety under section 70 of the *Gas Act 2000*

Gas Fitting (Natural Gas) Type B Appliance (Restricted) - Covers gas fitting work for the installation, service and commissioning of Type B Gas Appliances.

Gas Fitting (Natural Gas) Type B Appliance - Covers gas fitting work for the installation, service and commissioning and modification of Type B Gas Appliances.

Note: A **Type B Appliance** means an appliance (including a second-hand appliance) that -

(a) is not a Type A appliance; and

(b) has a gas consumption rating in excess of 10 mega joules per hour -

and includes any components and fittings of an appliance complying with paragraphs (a) and

(b) that are downstream from, and including, the appliance's manual shut-off valve.

Note: A Type A appliance when used in an industrial/commercial application for which it is not intended is considered to be part of a Type B. An example of this is a certified direct-fired space heater used as the heating/ventilating device in a spray/bake paint booth.

The Director may impose any conditions to the Certificate of Competency if appropriate in accordance with regulation 41 of the Workplace Health and Safety Regulations 1998.

To apply for a certificate of competency in any category of Gas Fitting (Natural Gas), an applicant must –

- 1. Apply in a form approved by the Director.**
- 2. Provide proof of identity and age in the form of a copy of birth certificate, passport or drivers licence, certified by a Justice of the Peace or Commissioner for Declarations.**
- 3. (a)** Provide evidence of successful completion of a recognised natural gas training course or natural gas up skilling program in the class of Gas Fitting (Natural Gas) to which the application relates.

Note: Further information concerning Gas Fitting training can be obtained by calling The Tasmanian Skills Institute (formerly TAFE) on Telephone: 1300 362 175.

(b) Applicants for a **Type B Restricted or Type B Gas Fitting (Natural Gas) COC** will also need to provide evidence of successful completion of an Independent Certificate Assessment, conducted

by Workplace Standards Tasmania. The Assessment will be comprised of theoretical and practical components in the class of Gas Fitting (Natural Gas) to which the application relates.

Note: Applicants for a **Type A Gas Fitting (Natural Gas) COC** do not have to undertake the Independent Certificate Assessment.

OR

4. Provide evidence of a licence/registration/certificate from another Australian State, New Zealand, or other country in Gas Fitting (natural gas) that is acceptable under the ANZRA or Mutual Recognition Agreement plus a log of relevant work undertaken in the previous three years.
5. Payment of the relevant certificate of competency fee (Refer to current schedule as per Application for Certificate of Competency in Gas Fitting (Natural Gas)).

Note: The certificate of competency will be issued for a period not exceeding three years.
